#### 1. BACKGROUND

The Government of India has received a loan of USD 200 Million from the International Bank for Reconstruction and Development towards the cost of Technology Centre Systems Programme (TCSP), and it is intended that part of the proceeds will be utilized for payments under the Contract(s) to be placed for Procurement of Machines and Equipment against this ICB.
