Centre for the Development of Glass Industry (CDGI), Firozabad, has been set up by Govt. of India in collaboration with UNDP/UNIDO and Govt. of UP. The Centre for the Development of Glass Industry is a Government of India Society, Registered under Societies Registration Act and is functioning as autonomous body under Ministry of Micro, Small & Medium Enterprise, Government of India. The main objective of the Centre is to assist glass industry specially in Firozabad for improving its overall performance particularly in the areas of technology upgradation, energy conservation, introduction of value added glass articles and skill development.

The Principal Director, being the Executive Head of CDGI, shall be responsible for day-to-day management and affairs of the Society and shall exercise his powers under the direction, superintendence and control of the Chairman of the Governing Council. It shall be the duty of the Principal Director to coordinate and exercise general supervision over all the activities of the CDGI.

Applications are invited from citizens of India for the post of Principal Director in CENTRE FOR THE DEVELOPMENT OF GLASS INDUSTRY, FIROZABAD, which is proposed to be filled up on contract basis for a period of 5 years initially with further extension based on the review of performance of the individual. The details regarding eligibility condition etc. are as under:

Educational Qualification

- a. Essential :** Degree in Ceramic/Silicate/Glass Technology or equivalent with Glass as a main subject from recognized University or Institute.
- b. Desirable :** Post Graduate degree in Ceramic/Silicate/Glass Technology or Management from recognized University/Institution.

Experience

- a. Essential :** 15 years experience in Production/Research in a glass/ceramic industry/R&D Organization in a responsible position.
- b. Desirable :** Experience in Implementation & Management of glass projects and manufacture of different type of glasses/glass products. Experience in financial, personnel management and general administration. In case of exceptionally deserving suitable and meritorious candidates, requirements of experience can be relaxed at the discretion of Chairman, Governing Council.

- c. Scale of Pay :** Rs.14,300-400-18,300 (pre-revised) (Pay scale-Rs.37,400 to 67,000/-, Grade pay-Rs.8700/- & Pay Band – 4 as per 6th CPC revised pay Rules). carries allowances as per government rules.

- d. Age :** Not exceeding 50 years (relaxable up to 5 years for departmental candidates and employees of Govt. and semi Govt. organization).

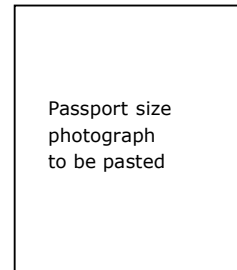
