**1. PROJECT BRIEF**

Ministry of Micro, Small & Medium Enterprises, Government of India is implementing a World Bank Funded Project i.e. Technology Centre Systems Programme (TCSP) amounting to USD 400 Million and it is intended that part of the proceeds will be utilized for payment against the contract to be finalized with the Service Provider for 'Portal Development & Enterprise Resource Planning (ERP) Implementation' for which the process has been initiated through this REoI.

**3. ELIGIBILITY**

- The consultant must be a registered legal entity in India and must be operational in India for at least last five financial years. The consultant must have valid SEI CMM Level 5 certificate.
- The consultant must have minimum annual average turnover of USD 10 million in the last three financial years from its IT business.
- The consultant should have experience on IT Projects awarded by Central/State Government/PSU in India involving designing and development of IT Systems.
- The consultant should have experience on Projects involving customization of the proposed ERP.
- The consultant must have a prior experience of digital content development in online learning domain including Digitization of content & scripting, Creation of online lectures, video production & packaging.

**2. ASSIGNMENT**

It is the intent of the Government of India to appoint Service Provider for 'Portal Development & ERP Implementation'. The services will include:

- Implementation of common Enterprise Resource Planning (ERP) to cover all the major functions of Technology Centres (TCs), Testing Centres and Testing Stations.
- Creation of Online Portal for Monitoring & Evaluation of TCSP and TCs, Provision of unified platform for all schemes of Ministry of MSME, and Public Procurement Service for MSMEs.
- Digitization of training content of Technology Centres (TCs).

**4. SUBMISSION OF EoI**

Expressions of Interest must be submitted online only at CPPP website: <https://eprocure.gov.in/eprocure/app>. The bidders would be required to enrol/register on this website. For submitting bids, the bidders are required to have Digital Signature Certificates issued by any certifying authority of India as indicated in the website. The last date for the submission of the documents is **26 October 2016 (1600 Hours Indian Standard Time)**. Manual bids shall not be accepted.
