
2. The In-charges of MSME-DFOs are required to ensure/adhere to the following:

- I. Procurement and Marketing Support scheme guidelines issued vide OM 5(1)/2021-22/PMS/SFC & Scheme Guideline dated 26/07/2022 to be followed for organizing the programmes.
- II. Funds are under the Plan Scheme and non- recurring in nature and advance may be drawn as per procedure.
- III. MSME-DFOs will keep separate accounts utilization for the sanctioned fund, The saving, if any, is not transferrable.
- IV. MSME-DFOs are required to furnish complete report upon completion of the programme along with photographs/relevant details to DFO- Division of O/o DC (MSME) including the following output/outcome parameters:-
 - (a) Topics/Schemes covered.
 - (b) Total no of participated in the programme
- V. The funds must be utilized as per component "5(II)(E): Organizing National Workshops/ Seminars by the Ministry/ O/o DC(MSME)" of Procurement and Marketing Support guidelines.
- VI. MSME-DFOs should ensure the utilization of sanction amount within this financial year.
- VII. Procurement of permanent assets from the programme sanction is not allowed and the proposed expenditure should cover the Hiring of Venue, Audio -Video, Refreshment, Business Lunch/Dinner, Banner, Printing & Stationary, Advertisement, Hiring of Vehicles, TA/DA to officials and non officials, Miscellaneous etc and while utilizing the sanction, Implementing agency should follow the GFR norms.
