2. The MSME-DFO should adhere to:-

- Funds are under the plan scheme and non-recurring in nature.
- MSME-DFO will keep separate accounts utilization for the sanctioned fund. The saving, if any, is not transferrable.
- The assets acquired wholly or substantially out of these funds should not, without the prior sanction of Government of India, be disposed or encumbered or utilized for the purpose other than that for which the funds have been sanctioned.
- The progress report on utilization of the sanctioned fund should be sent within a month after the completion of the event.
- The fund must be utilized as per the guidelines under the component 5(I)(B) i.e "Organising Trade Fair/ Exhibition held across the country" as mentioned in Procurement and Marketing Support Scheme guidelines dated 26.07.2022.
- MSME-DFO should ensure the utilization of sanction amount within current financial year as per GFR
