2. The Directors/Dy. Directors (in-charge), MSME-DIs should adhere to :

- Efforts should be made to select the participants from SC / ST / Women / PH / Minority categories.
- Funds are under the Plan Scheme and non-recurring in nature.
- MSME-DIs will keep separate account of utilisation for the sanctioned fund. The saving, if any, is not transferrable.
- The assets acquired wholly or substantially out of these funds should not, without the prior sanction of Government of India, be disposed or encumbered or utilised for the purpose other than that for which the funds have been sanctioned.
- The progress report on utilisation of the sanctioned fund should be sent periodically / within a month after the completion of the concerned trade fairs / exhibitions.
- The fund must be utilised as per the guidelines under the component – Domestic Trade Fairs / Exhibitions of the existing MATU Scheme.
- MSME-DI should follow the procedure prescribed under the GFR and the various guidelines under the economy measures.
