**1. PROJECT BRIEF**

Office of the Development Commissioner (MSME), Ministry of MSME, Government of India is in the process of upgrading and expanding the network of Technology Centres (TCs) - also referred to as Tool Rooms & Technology Development Centres by upgrading existing TCs and establishing 15 New TCs at a total Project cost of INR 2,200 crores including World Bank funding of USD 200 million under the Technology Centre Systems Programme (TCSP). **3. ELIGIBILITY**

Firms will be shortlisted based on the following criteria:

- Firm must be a registered legal entity and should have been in existence for at least 5 years.
- Average annual turnover in last 3 years
- Annual turnover in last three years from technology development projects in respective sector
- Experience of the firm in undertaking projects in the field of Technology development in respective sector in the last 5 years.

**2. ASSIGNMENT**

It is the intent of the Government of India to appoint three Manufacturing Technology Partners (MTP) for Fragrance and Flavour Sector, Footwear Sector and Glass Sector. The services of the MTPs will include:

- Support up gradation of existing TCs – FFDC Kannauj, CFTI Agra & Chennai and CDGI, Firozabad and augment services being offered by them
- Support TCs to improve the productivity & competitiveness of MSMEs in the respective sectors

**4. SUBMISSION OF EoI**

Expressions of Interest must be submitted online only at Central Public Procurement Portal <https://eprocure.gov.in/eprocure/app>. Interested firms would be required to enrol/register on the website. For submission of the EoI, the firms are required to have a Digital Signature certificate issued by any certifying authority of India as indicated on the website. The last date for the submission of the documents is **27 October 2016 (1100 hours Indian Standard Time)**. Manual Expressions of Interest(EoI) shall not be entertained.
