1. **Size of the stalls will be (9 Sqm) and charges will be Rs. 74,000/- per stall, and for SC/ST/NER/Women Enterprises, Rs. 53,000/- per stall of 9 Sqm. The Demand Draft will be made in favour of PAO, MSME, New Delhi. No cash payment will be accepted.**
2. The applicant Company /Firm / Unit has to submit the UNDERTAKING on their letter head as per **Annexure-A**
3. The charges of stall will be for the period 14th – 27th November 2014.
4. In case of cancellation of Stall after the allotment the Charges paid will be forfeited.
5. Participants will be allowed to sell their products in the exhibition.
6. Payment of all applicable taxes on sale etc. will be the responsibility of exhibitors.
7. Cost of transportation of exhibits from the unit to exhibition and back will be borne by the units themselves.
8. Items in the stall will be provided as per the IITF standard package by ITPO.
9. No additional display space will be provided in the exhibition.
10. Exhibitor passes will be issued to persons managing the stalls by IITF. For which two photographs are required. Maximum two persons are allowed at each stall.
11. The stalls are not transferable and **Sharing of the stalls is not allowed.**
12. Exhibitors should ensure not to change the exterior layout of the stall allotted to them and not use any area outside the stall or the aisle.
13. Exhibitors are liable for compensation of any damage to the furniture fittings or any other property, caused due to their negligence.
14. Smoking is strictly prohibited in the exhibition hall.
15. Tentative timings of the exhibition will be from **10.00 a.m. to 8.00 p.m.**
16. The Exhibitors required if any additional items in the stall are required to pay extra to the event organizing agency.
17. The exhibitors are sole responsible for any theft in their stall. However, the security arrangements have also been made after the exhibition hours.
