ORDER

Cancellation of Offer of Appointment to the post of Stenographer Gr.II

Whereas, Sh. Shubham Kumar, D.O.B. 09.02.1996, Roll No. 2201043234 has been nominated by the SSC for the post of Stenographer Gr.II vide letter no. 12/1/2020-ND-II (D-45) I dated 09.01.2021 on the basis of final results of the Stenographer Grade 'C' & 'D' Examination, 2018 declared by Staff Selection Commission on 28.11.2020 and accordingly an Offer of Appointment was issued to him vide MSME-Development Institute, Ahmedabad letter no. A-12012(4)/2021-22/19 to 23 dated 01.07.2021, second opportunity was given to him on his request dated 22.07.2021 vide MSME-DI, Ahmedabad e-mail dated 26.07.2021 and the final opportunity was given vide letter no. A-12012(4)/2021-22 dated 20.04.2022 and 06.05.2022.

2. And whereas, Sh. Shubham Kumar did not report in person on the scheduled date and time as given in the offer of appointment issued to him for dated 26.07.2021, second opportunity issued to him for dated 30.08.2021 and the final opportunity for dated 16.05.2022. He neither has intimated any reason to MSME-DI, Jaipur for not reporting on duty.

3. As per the DoPT Office Memorandum No. 1259494-Estt.(D) dated 09/08/2017 wherein Para 1, the following has been mentioned:-

*"The offer of appointment would lapse if the candidate did not join within the specified period and would lapse automatically after the expiry of six months from the date of issue of the original offer of appointment"*

4. Therefore, in view of the facts and circumstances as mentioned above and since the candidate has wilfully chosen not to respond to the letters dated as mentioned above, the candidature in respect of Shri Shubham Kumar, Roll No. 2201043234 is hereby cancelled and the dossier returned to the SSC.
