- 6. The MSME-DIs/TCs shall keep separate account of utilization of these funds for each programme/Component. The saving, if any, is NOT TRANSFERABLE.
- 7. Procurement of permanent assets from the programme sanction is not allowed.
- 8. The MSME-DIs/TCs should follow the procedure prescribed under GFR and the various guidelines under the economy measures.
- 9. Director of MSME-TCs will report completed numbers of training programmes in the monthly progress report in prescribed format on MIS through Directors, MSME-DIs.
