


2. The inter-se-seniority of the aforementioned officers will be as mentioned in the table above.

3. All the above officials are directed to join at their place of posting on promotion, as mentioned against their names, latest by 31.01.2026, failing which their non-joining will be treated as ‘refusal of promotion’ and he/she will be debarred for promotion for a period of one (01) year or till the next vacancy arises, whichever is later, as per DoPT O.M. No.22011/5/86-Estt (D) dated 10.04.1989. Additionally, he/she will also not be eligible for further financial up-gradation as per DoPT O.M. No.35034/3/2008-Estt (D) dated 19.05.2009. Further, on the eventual promotion in the higher grade, they will lose seniority vis-a-vis their juniors promoted to the higher grade earlier.



4. All the above officials may submit their option for fixation of pay under Rule FR 22(I)(a)(I) within one month of assumption of charge. The pay of the official on appointment to Office Superintendent, (Level-6) will be fixed in terms of CCS(RP), Rules, 2016 and DoPT OM No. 13/02/2017-Estt.Pay (Pay-I) dated 27.07.2017.
