It is to kindly inform you that ITPO has revised the space rent charges to Rs. 10,500 per sq. mtr. for the above subject fair. For two side open stall 10 % extra will be charged. The details of DDs required as per the space requirement is given below:-

As you may aware that the DDs are valid for 03 months only from the date of issue. Therefore, in order to avoid the problem of validity, the date of issue of DDs should be after July 13, 2015.

Please note that the above rates for the subject fair are approved and final as informed by ITPO, New Delhi.
