APPORVAL OF DESIGN CENTRES

As there is no grant component for the design centres in the scheme, attempt should be made to open as many design centres as possible, particularly in the remote corners of the country where artisans/rural entrepreneurs need design support.

Following design centres were proposed:

- 1. All 15 TCs and 59 MSME DIs/Branch DIs were proposed for opening a Design centre and invite proposals/projects both from MSMEs for professional designs and also student design projects. These designs shall not only be industrial designs but also designs relating to artisans, handicrafts, and such other areas where design is the biggest handicap for MSMEs in accessing markets. Targets of 5 student design projects and 5 professional design projects were proposed to be given to each TC and DI/Br DI to be submitted by 31st December 2019.
- 2. Kishkinda trust, Hampi working with artisans in bamboo cluster and handicrafts
- 3. One MSME design centre in collaboration with CII, for which proposal shall be sent by them
- 4. One MSME design centre in collaboration with India SME Forum for which proposal shall be sent by them
- 5. MSME Design centres in M/o HRD supported design institutions for which proposal shall be sent by them
