Minutes of the 2nd Meeting of Project Monitoring and Advisory Committee (PMAC) for Implementation of Scheme "Building Awareness on Intellectual Property Rights" for MSMEs under CLCS-TUS held on 2.00 PM, 04.12.2019 at O/o DC(MSME).

The 2nd meeting of Project Monitoring and Advisory Committee (PMAC) for implementation of Scheme "Building Awareness on Intellectual Property Rights" for MSMEs under CLCS-TUS was held on 04-12-2019, under the Chairmanship of Special Secretary and Development Commissioner, Ministry of MSME, New Delhi.

List of participants in the meeting is annexed (Annexure-I).

Ms. Mandeep Kaur, Joint Development Commissioner welcomed the SS & DC (MSME) & Chairman of the committee alongwith other members of the committee. The Chairman and members agreed upon the following:-

Agenda Item No. 1

29 Nos of Proposals submitted by various organizations for setting up IP Facilitation Centre as per Annexure (i) were reviewed in the meeting. The committee has recommended for the approval of all these proposals submitted by these organizations subject to approval of the sub-committee to be constituted for this purpose. The PMAC has viewed that these organizations will submit their business plan and budget requirement to run these centres.

A sub committee under the chairmanship of DDG Sh. D P Srivastava will be constituted for evaluation of the submitted business plan and financial approval for these IPFC projects. The committee will, in addition to having official members and a nominee of IFW, will have experts from the technical institutions.

PMAC directed to approve all proposals, subject to the condition that these IPFCs shall be self sufficient. Grant shall be linked to the business they generate. They will engage an IP lawyer to give legal support to the MSMEs in their area to apply for different IPRs and also for creating awareness amongst the MSMEs about their IP rights. Their business plan shall be evaluated based

on the work they have done so far in the field of IPR and how they propose to become self sufficient after the grant period is over. Those organizations which had set up IPFCs under the scheme and have closed the centres after taking grant shall not be given any further grant.

One IPFC each was approved for all MSME Technology centres.

Agenda Item No. 02

Proposal submitted by various organisations for 77 Nos of National /Regional Level Seminar/Workshop conclave/Exhibition as per Annexure (ii) have been approved by the PMAC with the condition that these organizations shall be linked with the nearest IPFC of their region to organize these programmes and no stand alone programme should be allowed. Every programme ought to be output linked. E-brochures, case studies, videos depicting the success stories of MSMEs should be uploaded on the MIS.

Agenda Item No.3

The PMAC has approved the reimbursement of 14 Nos of Patents (Indian/Foreign) and 46 Nos of Trademarks to MSMEs as per Annexure (iii) subject to furnishing of requisite documents as deemed fit.

Agenda Item No. 4

- (i) Proposal for Pilot Studies on IPR submitted by TBI BITS Pilani Hyderabad has been prima facie rejected by the PMAC as proposal had no substance.
- (ii) PMAC has approved and sought for proposals for conducting studies on IPR related issues. These studies may be conducted by IPFCs or other organizations. IPFCs shall also be asked to develop an IP profile of the state/ IP portfolio of the different clusters under the project. The sub committee constituted above shall be empowered to evaluate all the proposals and submit to AS&DC for approval with IFW concurrence.

Agenda Item No. 5

Proposal submitted by Indian Institute of Corporate Affairs for interaction with International Agencies has not been approved as proposal was incomplete.

Agenda Item No. 6

PMAC has approved for financial support of Rs. 2.00 Cr for the Activities under Advertisement & Publicity through PPDC–Agra (NMIU–Secretariat). A detailed action plan for wider publicity of the scheme may be planned which includes publishing of e-brochures, case studies and short films, print media, campaign on various social media platforms etc. PPDC Agra was directed to follow applicable DAVP norms for doing publicity and media campaigns.

Agenda Item No. 7

PMAC has approved for organizing 05 Nos of International Consultation on GI and other IPR Issues related to MSMEs through PPDC –Agra (NMIU – Secretariat) ,CTTC, Bhubaneswar, NRDC, India SME Forum and CII with GoI support of Rs. 15 Lacs for each programme. These organizations are required to submit their proposal within a weeks' time.

Agenda Item No. 8

PMAC has approved financial support of Rs. 01 Crore for various study visits on IPR domain to various National/International Agencies to develop a framework for best IPR management practices through cooperation & experience sharing, providing suitable linkages and cooperation with IPR offices in developed countries and other International agencies. Individual proposals need to be submitted by different organizations for training of MSME officials, IPFC officials industry associations and MSMEs. Sub committee constituted above shall evaluate the proposals and submit for approval of AS&DC, subject to IFW concurrence.

Agenda Item No. 9

The PMAC has approved for allocation of targets to MSME-DIs in respect of awareness programme allocated to them for the FY 2019-20. The success of these programmes to be measured in terms of IPR Filing, submission of reimbursement applications, IP Enforcement & Commercialization. The sub-committee constituted above will monitor the performance and allocate targets to the IAs.

Agenda Item No. 10

The committee has agreed for Empanelment of consultants for the implementation of CLCU-TUS IPR scheme. EOI for Empanelment of consultants was discussed and approved, subject to its IFW concurrence. These consultants shall be attached with IPFCs supported under the scheme for assisting MSMEs in IP related issues.
