Office Memorandum

Subject: Re-constitution of Project Implementation Committee (PIC) for Implementation of the Scheme "Building Awareness on Intellectual property Rights (IPR)" for MSMEs under NMCP-Regd.

Consequent to the decision of the Government of India to implement the scheme "Building awareness on Intellectual Property Rights" for MSMEs under the National Manufacturing Competitiveness Programme (NMCP), it has been decided to re-constitute the Project Implementation Committee (PIC) for the implementation of the Scheme. The terms of Reference (TOR) of this committee will be as follows:-


- i) To examine and recommend approval of proposals, including disbursement of funds for the purpose of achieving the objectives envisaged under the scheme.
- ii) To suggest, criteria for considering proposals /Projects under the Scheme.
- iii) Ensuring successful and timely implementation of the programme.
- iv) Ensure adequate and timely funds flow to the eligible beneficiaries.
- v) To Suggest /highlight specific issues related to scheme, which may emerge during the implementation of IPR programme by the committee.
- vi) Regular reporting to the steering committee regarding implementation of the programme and to seek guidance /direction on specific issues /matters relating thereto.
- vii) TA/DA will be paid to the non-official members of the Committee / Special invitees as per rules for attending the meeting.
- viii) Committee will meet atleast once in two months.
- ix) To perform such other functions as may be assigned to it by the Steering Committee from time to time.
