### Sanction Order

**Sub :- Sanction for Allocation of Rs. 2,00,000 (Rupees Two Lakh Only) to MEME-DI Guwahati under 'Other Administrative Expenses' for implementation of the scheme "Promotion of MSMEs in NER and Sikkim" for the financial year 2020-21.**

Undersigned is directed to convey the sanction by the competent authority for allocation of funds of Rs. 2.00 lakh (Rupees Two Lakh only) towards recurring Grant-in-Aid under Other Administrative Expenses (OAE) Head for carrying out the activities to implement the scheme "Promotion of MSMEs in NER and Sikkim" for the financial year 2020-21.

2. The Funds will be regulated in accordance with the provisions contained in the scheme/guidelines. The funds released are also subject to the provisions contained in Chapter 9 of the General Financial Rules 2017, as amended from time to time, read with the Government of India's decisions incorporated thereunder, and any other guidelines which may be issued in this regard, and in particular to the following conditions :-

- i) The Funds shall be utilized for implementation of Scheme "Promotion of MSMEs in NER and Sikkim" only.
  - ii) While incurring the expenditure austerity measures should be taken into account as issued from time to time by competent authority.
  - iii) The MSME-DI Guwahati will keep separate record of utilization of these funds. The funds and savings, if any are NOT TRANSFERABLE.
  - iv) The assets acquired wholly or substantially out of these funds should not, without the prior sanction of the Government of India, be disposed or encumbered or utilized for the purpose other than that for which the funds have been sanctioned.
  - v) Director of MSME-DI will send the progress report after completion of the activity.
  - vi) Director of MSME-DI may use the funds as per prescribed scheme guidelines relating to implementation of the scheme. The expenditure under the sanction is maximum and for financial year 2020-21 only. Saving, if any, will be surrendered to the Government.
  - vii) The MSME-DI will follow the procedure prescribed under GFR including the various guidelines issued from time to time under the economy measures.
