### WORK ORDER

**Sub: Work order w.r.t release of Rs. 5,68,000/- under Grant in Aid General to ICRISAT, Patancheru, Telangana as 5th and final instalment for Intellectual Property Facilitation Centre (IPFC) for MSMEs, under the Scheme "Building Awareness on Intellectual Property Rights for MSMEs" in the F.Y. 2019-20- reg.**

I am directed to convey the execution of work order w.r.t. the release of **payment of Rs. 5,68,000/- (Rupees Five Lakh Sixty Eight Thousand only)** under Grant- in-aid to ICRISAT, Patancheru, Telangana as 5th and final instalment for Intellectual Property Facilitation Centre (IPFC) for MSMEs, under the Scheme "Building Awareness on Intellectual Property Rights for MSMEs" in the F.Y. 2019-20:

1.	ICRISAT, Patancheru, Telangana	5th and final instalment for Intellectual Property Facilitation Centre (IPFC) for MSMEs	Rs. 5,68,000/-

2. ICRISAT, Patancheru has to ensure their minimum contribution of Rs. 1,60,000/- (Rupees One Lakh Sixty Thousand only) during the operation of ICRISAT, Patancheru. The Govt financial assistance of Rs. 59.12 Lakh (Rupees Fifty Nine Lakh Twelve Thousand only) as 1st, 2nd, 3rd and 4th instalment were released to ICRISAT, Patancheru vide sanction of even number dated 05.05.2015, 01.12.2016, 29.05.2018 & 12.02.2019, for setting up of IPFC at Patancheru prior to this sanction.

3. As an annual target, the IPFC should assist MSMEs in filing atleast six patent applications, ten applications for registration under Industrial Design, one application for registration under Geographical Indications and 20 applications of Trademarks. Also atleast one success story for commercialization, transfer of technology and protection under trade secrets, etc. may be forwarded to this Office. Further, as per the IPR-Scheme Guidelines, ICRISAT, Patancheru, Telangana should develop an in-built mechanism in

consultation with the members of the Steering Committee for the sustainability of the IPFC. The steps in this regard may be informed to this Office at the end of each month. In addition to above ICRISAT, Patancheru may ensure this Office on the sustainability of IPFC.

4. The sanction of the Competent Authority is accorded for the release of Rs. 5,68,000/- as 5th and final instalment for setting up of an Intellectual Property Facilitation Centre at Patancheru, Telangana, the unspent balance amount has been taken into the accounts. It is also certified that no UC due for rendition from previous years is pending with ICRISAT, Patancheru.


5. ICRISAT, Patancheru shall raise a pre-receipt bill (in duplicate) for receiving an amount 5,68,000/- (Rupees Five Lakh Sixty Eight Thousand only) for the "IP Facilitation Centre for MSMEs at Patancheru.

6. The above mentioned work is to be carried out in accordance with the terms and conditions mentioned in the earlier sanction orders issued by this office dated 16.09.2019, 19.12.2019 & 31.12.2019 and as per scheme guidelines of **Building Awareness on Intellectual Property Rights**.

7. The progress of implementation of **Building Awareness on Intellectual Property Rights** and expenditure incurred shall be submitted regularly for monitoring by the Project Monitoring and Advisory Committee (PMAC), O/o DC (MSME).


