Subject : **One-time relaxation of 31 days to all nodal banks/agencies for submission of online applications for claims under Credit Linked Capital Subsidy Scheme (CLCSS)**

I am directed to convey the decision of competent authority that all nodal banks /agencies under CLCSS i.e., SIDBI, SBI, PNB, BOB, NABARD, BOI, SBBJ, Canara Bank, Indian Bank, TIICL, Corporation Bank & Andhra Bank are allowed one-time relaxation of 31 days due to present workload on banks after demonetization. This is to be noted that the relaxation is applicable for eligible claims of Third Quarter of 2016-17 (October-December, 2016, ending on 31.12.2016) only and PLIs/co-opted PLIs can now submit claims upto 31st January, 2017. The grace period already given for submission of application from Level – 2 (Nodal Banks / Agencies) to Level – 3 [Office of DC (MSME)] will remain same. From the 4th Quarter of 2016-17 ending on 31st March, 2017 onwards, the one-time relaxation in submitting the claims by PLIs / co-opted PLIs will not be applicable.
