1. (i) the Govt. of India will reimburse the 75 percent of air fare by economy return class **(100% to SC/ ST/ Women Entrepreneurs & entrepreneurs from NE Region)**.
 (ii) 50 percent subsidy on space rent **(100% to SC/ ST/ Women Entrepreneurs & entrepreneurs from NE Region)**.
 (iii) The total subsidy on air fare and space rent will be restricted to Rs.1.25 lakhs per unit.
 (iv) Any unit can avail of this facility only once in a financial year
 (v) Only one person of the participating unit would be eligible for subsidy on airfare.
 (vi) The offer is available on **first come first serve** basis till space is available.

Application will be accepted through Director, MSME-DI with 50% space rental charges of the booked space (Min. 6 sq.mtr.) by Demand Draft in favour of PAO (MSME) (from general category of entrepreneurs only), a copy of registration certificate and passport details/ copy of their visiting representatives on or before last date.
