**1. BACKGROUND**

The Government of India has received a loan of USD 200 Million from the International Bank for Reconstruction and Development towards the cost of Technology Centre Systems Programme (TCSP), and it is intended that part of the proceeds will be utilized for payments under the Contract(s) to be placed for Procurement of Testing and Calibration Equipment against this ICB.

**2. INVITATION OF BIDS**

The Development Commissioner (MSME), Ministry of MSME, Government of India now invites sealed bids from eligible and qualified bidders for the Procurement of Testing and Calibration Equipment required for Institute for Design of Electrical Measuring Instrument (IDEMI), Mumbai REF: ICB No. 21/ TCSP/ GOODS/ P1/ 2015/ TR/ TC (Package - 1).
