1. PROJECT BRIEF

Office of the Development Commissioner (MSME), Ministry of MSME, Government of India is in the process of upgrading and expanding the network of Technology Centres (TCs) - also referred to as Tool Rooms & Technology Development Centres by upgrading existing 18 TCs and establishing 15 New TCs at a total Project cost of INR 2,200 crores including World Bank funding of USD 200 million under the Technology Centre Systems Programme (TCSP). 3. ELIGIBILITY

- i. The firm must be a registered legal entity and should have been in existence for at least 5 years
- ii. Must have at least 3 relevant completed/ ongoing projects in applied research in the relevant sector in the last 5 years.
- iii. Must have at least 3 relevant completed/on-going projects related to skill development specifically development of training programs and curriculum in the relevant sector in the last 5 years.
- iv. In addition, for each manufacturing technology partner package there are shortlisting criterions based on the average annual turnover and turnover from applied research in relevant sector.
