A pre-bid meeting was held today on 21.4.15 at 3.00 PM in the committee room, office of DC,MSME, Nirman Bhawan under the Chairmanship of Sh. R.K.Pandey, Joint Development Commissioner, O/o DCMSME, for the prospective bidders for the NCB to supply 17 lots of Testing and Calibration equipment for IDEMI under World Bank assisted Technology Centre Systems Programme. At the outset, Shri Ramesh Kumar Pandey, Joint Development Commissioner welcomed all the designated representatives, present in the prebid meeting and gave a detailed background of TCSP.
