SELECTION OF CONSTRUCTION MANAGEMENT CONSULTANT TECHNOLOGY CENTRE SYSTEMS PROGRAMME - A WORLD BANK FUNDED PROJECT

1. PROJECT BRIEF

Office of the Development Commissioner (MSME), Ministry of MSME, Government of India is in the process of upgrading and expanding the network of Technology Centres (TCs) - also referred to as Tool Rooms & Technology Development Centres by upgrading existing 18 TCs and establishing 15 new TCs at a total Project cost of INR 2,200 crores including World Bank funding of USD 200 million under the Technology Centre Systems Programme (TCSP). 3. ELIGIBILITY

- The firm/company must be a registered legal entity and should have been in existence for the last 10 years.
- The firm/company must have a minimum average annual turnover of INR 100 crores over the last 3 years.
- The firm/company should have rendered services pertaining to construction management & supervision for civil, electrical, HVAC, interior & mechanical works for Government / Semi Government/corporate client.
- The firm/company should not have been blacklisted by any government entity or World Bank.

2. ASSIGNMENT

It is the intent of the Government of India to appoint a Construction Management Consultant (CMC), with design and supervision of construction work as core business area, to provide design and construction management services for new & existing TCs including:

- Preparation of detailed concept design & subproject appraisal reports, carrying out contract planning and preparation of detailed engineering designs, schedules of quantities & specifications
- Preparation of scope of work & technical bid documents for appointment of Construction Works Contractor (CWC)/Turnkey Construction Agency (TCA) and supporting PMU through technical inputs during bid process management
- Supervision of construction; managing the contract; monitoring construction activities
- Certifying contractor's progress claims, carrying out quality control, testing, preparing progress and monitoring report & certifying bills
