The Technology Centre Systems Programme will support in upgrading the existing Technology Centres (TCs) - also referred to as Tool Rooms and Technology Development Centres - and establishing up to 15 new TCs. The TCs are to be located in various parts of the Country and cater to the needs of small and medium firms in the field of training, component designing, tooling and manufacturing. The Office of Development Commissioner, Micro Small Medium Enterprises intends to hire consulting firms in the role of Construction Management Consultant (CMC) to provide design and construction management service for the construction of new TCs and up-gradation of existing TCs. The construction work for various TCs shall be taken up under TCSP which shall be implemented over a period of six years. The estimated construction cost for above mentioned existing and proposed new TCs is INR 420 Crore.

This request for EoI is intended at hiring a Construction Management Consultant (CMC) to provide construction management service. The CMC must have design and supervision of construction work as core business area. The Construction Management Consultant (CMC) shall be responsible for designing, supervision of work and final closure of construction works for each TCs:

- 1. CMC will prepare detailed concept design and subproject appraisal reports, carry out contract planning and detailed engineering designs based on broad design provided by the client; prepare schedules of quantities and specifications
- 2. CMC will prepare scope of work and technical bid documents for appointment of Construction Works Contractor (CWC)/Turnkey Construction Agency (TCA) and support PMU with technical inputs during the bid evaluations for the CWC/TCA e.g. response to technical queries, evaluation of technical approach, work schedule etc.
- 3. CMC will supervise the construction; manage the contract; monitor construction activities.
- 4. CMC will certify contractor's progress claims, carry out quality control, testing; and prepare progress and monitoring reports, and certify bills.

The Office of DC-MSME now invites eligible consulting firms ("Consultants") to indicate their interest in providing the services. Interested consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the services. The short listing criteria are:

- 1. The firm / company must be a registered legal entity and should have been in existence for the last 10 years.
- 2. The firm/company must have a minimum average annual turnover of INR 100 crores over the last 3 years.
- 3. The firm / company should have rendered services pertaining to construction management & supervision for civil, electrical, HVAC, interior & mechanical works for Government / Semi Government/corporate client.
- 4. The firm/company should not have been blacklisted by any government entity or World Bank.

The attention of interested consultants is drawn to paragraph 1.9 of the World Bank's *Guidelines:* Selection and Employment of Consultants [under IBRD Loans and IDA Credits & Grants] by World Bank Borrowers (January 2011) ("Consultant Guidelines"), setting forth the World Bank's policy on conflict of interest.

Consultants may associate with other firms in the form of a joint venture or a subconsultancy to enhance their qualifications and they must mention the nature of association whether Joint Venture or Subconsultancy, in their Eol.

Consultants will be selected in accordance with the Quality Cost Based Selection (QCBS) method set out in the Consultant Guidelines.
