2. The In-charges of MSME-DFOs are required to ensure and adhere to the following:

(i) Procurement and Marketing Support scheme guidelines issued vide OM 5(1)/2021-22/PMS/SFC & Scheme Guideline dated 26/07/2022 to be followed for organizing the VDPs.

(ii) Funds are under the Plan Scheme and non- recurring in nature.

(iii) MSME-DFOs will keep separate accounts for utilization for the sanctioned fund, The saving, if any, is not transferrable.

(iv) It is to be ensured that every event is led by business and data for each event along with participants has to be captured for follow up action and also to do performance audit.

(v) A minimum of 100 MSMEs should participate in each programme. Efforts should be made to select maximum possible number of participants from SC, ST, OBC, Women, Divyang and Minority categories.

(vi) MSME-DFOs will furnish complete report on completion of the programme along with photographs/relevant details to PMS Division/O/o DC (MSME) including the following Output/Outcome parameters prescribed by NITI Aayog:-

- (a) No. of CPSEs participated in the programme.
- (b) Total no of MSMEs participated in the programme.
- (c) No. of MSEs successfully registered themselves as vendors of CPSEs.
- (d) No of MSMEs exhibited their products/services in the exhibition.
- (e) No. of MSMEs successful in getting/generating business through the programme by exhibition of products, B2B/B2C etc.
- (f) Approximate value (*Amount in INR*) of business generated by MSMEs through the programme by exhibition of products, B2B/B2C etc.

(vii) Monthly Progress Report in the prescribed format to be filled/submitted on regular basis.

(viii) The fund must be utilized under the component 5(I)(C): CPSE level Vendor Development Program cum Exhibition of Products as per scheme guidelines.
