
In partial modification to this office Sanction No. 41/CLCS-TUS/PMAC/ZED/2020-21 dated 20.05.2022 amounting to Rs. 1,31,10,000/- (Rupees One Crore Thirty One Lakh & Ten Thousand Only) for conducting 240 awareness programme (face to face and virtual) for implementation of MSME Sustainable (ZED) certification scheme for FY 2022-23 to MSME-DIs, the entry at S. No. 4 is as below :

S. No.4	MSME-DIs will conduct awareness programme, followed by organizing registration Camps in different locations. Minimum no of registration camps will be 10 times of the no of awareness programme. Each registration camps shall ensure at least 20 MSMEs get registered under ZED registration. (Ex. If one MSME DI has been allocated 4 awareness programme then the DI will have to organize minimum 4X10=40 registration camps) Each registration camps shall ensure at least 20 MSMEs get registered under ZED registration. This will help to achieve 240X10X20=48000 MSMEs are ZED registered).

S.No.4	MSME-DFOs (erstwhile MSME-DIs) will conduct awareness programme inclusive of registration Camps. Efforts should be made for maximum no of ZED registration, so that target could be achieved for FY 2022-23.
