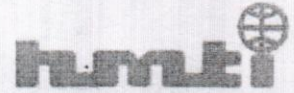

HMT(I) is currently implementing following projects on behalf of MEA, which are in procurement stage:


- Setting up of Indo-Myanmar Industrial Training Centre (IMITC) Thaton, Myanmar
