
**CIRCULAR**

**Subject:- Non-availability of APARs of officers who are at present Members of the newly created IEDS (Group B) for their promotion**

In continuation of Circular of even number dated 30<sup>th</sup> May, 2020, it is stated that, on receipt of the same, Shri G. Shanmuganathan, AIA, has, on the one hand, denied that there were no APARs of junior officials pending with him and, the Administration is trying to malign him but, on the other hand, in another mail sent on 16<sup>th</sup> May, 2020, he clearly mentioned that **he had reviewed/reported on APARs of only 5 out of 41 officials for his tenure as Director/AIA, at MSME-DI, Chennai and reviewed/reported APARs of 2 out of 16 officials for his tenure at MSME-TC, Chennai (Annexure-B of his mail is enclosed).**

2. The concerned officers whose names are mentioned in the list are requested to follow up with him for reviewing/reporting of their APARs for the relevant periods as per the list attached.
3. In case the list enclosed is not complete or contains some wrong information, the same may be brought to the notice of Headquarters Administration immediately.
4. This Circular is issued only for verification of records and finalising the proposals for promotion of IEDS officers for sending to the UPSC.
5. **All officers concerned are requested to pursue the matter with him officially, through mail, with CC to this office, mentioning in the subject the number and the date of the instant Circular, with proofs of submission of their APARs, to enable Admin. to issue NOCs to deserving cases.**
