With reference to sanction letter No. 65(08)/TC/Kolkata/2k-17-18, dated: 18/05/2018 on the above cited subject. In this regard, the undersigned is directed to convey the approval of Competent Authority for the withdrawal of unspent fund amounting Rs. 60,36,013/- (Sixty lakh Thirtysix Thousand Thirteen rupees) for the financial year 2018-19.

2. The withdrawal is necessitated in view of AS & DC's remarks on the proposal for purchase of the relevant machinery/ equipment that 'single tender not to be accepted, fresh tenders may be issued' on page 33/N on file of even no. dated 14.12.2018. If the fund is not withdrawn, it would remain unspent and there would be audit objections. TC Kolkata may reissue the tender at an appropriate time if deemed necessary with consequent expenditure in the next Financial Year. However, if the tender is to be reissued, a suitable intimation as regards the estimated expenditure may be sent immediately to Hqrs. for budgeting the amount in the next year's BE.
