4. The expenditure incurred in respect of each YP (on monthly basis) would be maintained by the respective MSME-DFOs and to be shared with PMV Division, O/o DC (MSME), on monthly basis, on the last day of the each month, on priority.
5. This issues with the approval of the Competent Authority and concurrence of IFW vide Dy. No. 66/2023-24/ US(IFW-II) dated 07.02.2024.
