- iii) The assets acquired wholly or substantially out of these funds should not, without the prior sanction of Government of India, be disposed or encumbered or utilized for the purpose other than that for which the funds have been sanctioned.
- iv) The Progress report on utilization of the sanctioned fund should be sent periodically/ within a month after the completion of the concerned trade fairs/ exhibition/seminars /awareness programs.
- v) The fund must be utilized as per the guidelines under the component 5(G): Organising National level Vendor Development Programme under "Procurement and Marketing Support Scheme (revised).
- vi) MSME-DIs should ensure the utilization of sanction amount with in this financial year.
- vii) MSME-DIS should follow the procedure prescribed under the GFR and the various guidelines under the economy measures.
- viii) The sanction amount should be utilized in the FY 2019-20 as per GFR-17.
- ix) MSME-DIs should make sure the mapping of PFMS and other prerequisites on the PFMS portal of the PMS scheme.
- x) Approval is subject to following conditions:
 - Detailed list of vendors and buyers alongwith the sector being covered who are proposed to be participating in this programme shall be uploaded on MIS.
 - GeM/UAM/GST counter shall be established.
 - No multi sector VDP shall be organised by the Programme implementing agency which has no defined outcomes.
 - Every VDP should result in identification of clusters/sectors/commodities which may be made export worthy or may be used for import substitution.
 - **Issues and constraints shall be identified and a detailed report sector wise shall be submitted on MIS before the bills are submitted to PAO for clearance.**
