4. Director I/c, MSME-DI, Agra should furnish statement for expenditure incurred and ensures utilization of fund within the current financial year 2020-21.


5. Director I/c, MSME-DI, Agra shall furnish fund utilization certificate along with installation and commissioning certificate.
