Sir,

- iii) Traveling allowance to be allowed as on tour from the place of posting to the place of training and back by the class of accommodation to which he/ she is entitled.
- iv) DA as per rules.

2. This sanction is hereby accorded to payment of;

- a) Course fee to the concerned training institute (as shown in Annexure, even dated) will be paid by Headquarter Office.
- b) Payment of **Rs.3,82,000/- (Rupees Three Lakh Eighty Two Thousand only) plus Service tax @ 15.00%** to IICA, Gurgaon as charges towards venue rent, faculty cost, stationary items , lodging and boarding etc .

3.1 The above mentioned course fee and charges towards venue rent, faculty cost, stationary items , lodging and boarding will be paid by this office on the receipt of pre-receipted bill in duplicate duly affixed with revenue stamp after the training programme is over and is debitable to the Major Head 2851, Minor Head 00.102 Sub Head 98.01.20 Other Administrative Expenses (OAE) under Demand No. 58 for the year 2016-17.
