

3. Director, MSME-DI (Mumbai and Haldwani) to ensure reimbursement of certification charges to MSEs is done strictly as per the procedure/ guidelines of ISO-9000/14001/HACCP Certification reimbursement scheme within budget allocated to them.

4. MSME-DIs shall reimburse the fund as per the proposal submitted to this office without deviation. No new proposal for reimbursement shall be accepted after this sanction. Details of beneficiaries shall be uploaded on the respective MSME-DI's website.






