I am directed to convey the approval of the Additional Secretary & Development Commissioner (MSME) for additional funds allocation of **Rs. 6, 00,000/- (Six Lakh rupees only)** for reimbursement of one time registration fee / annual recurring fee (75 % of fee paid by MSEs to GS1 India) under Bar Code scheme on demand to MSME-DI, Cuttack and MSME-DI, Jaipur during financial year 2016-17. The above funds are to be utilized by MSME-DI for reimbursement of 75% of one time registration fee/ annual recurring fee paid by MSEs to GS1 India for use of Bar codes and within the financial year 2016-17 as per the guidelines. The MSME-DI will keep separate account of utilization of these funds and shall not divert any part of the sanction to any other activities. Director, MSME-DI will have the overall responsibility for correctness, regularity and propriety of the exercise of the powers delegated to him by this office. Director, MSME-DI should send performance cum expenditure report on regular basis on the last day of the same month to this office.





3. The expenditure will be debit able as given below:

**For expenditure on one time registration fee / Annual recurring fee**

In BE 2016-17 of Bar Code Scheme under NMCP Scheme (Technology Upgradation and Quality Certification), total budget allocation is Rs. 2.00 Crore out of which under object head (95.01.33) (Subsidies) is Rs 1.50 Crore .Hence, the likely expenditure of Rs 6,00,000/- will be borne from object head (Subsidies) of Bar Code Scheme under Ministry of MSME, Demand No. 58, Major head –2851.00.102.95-Village and Small industries –Object head 95.01.33- for the year 2016-17 .
