2. In terms of the instructions contained in Para 17.12 of DOPT O.M. No. 22011/5/86-Estt (D) dated 10.04.1989, the above officials will not be considered for promotion for a period of one year from the date of refusal of promotion / deemed date of refusal of promotion mentioned against their name or till next vacancy arises, whichever is later. Further, on the eventual promotion in the higher grade, they will lose seniority vis-a-vis their juniors promoted to the higher grade earlier.

3. Additionally, they will also not be eligible for further financial up-gradation as per DoPT OM No.35034/3/2008-Estt (D) dated 19.05.2009.
