Based on the principle of rotation, it was decided at the last (25th) meeting of the Southern Zonal Council held on 16th November, 2012 at Bengaluru that the next meeting of the Council shall be held in Tamil Nadu during the period of July, 2013 to December, 2013.

The Zonal Councils provide a common meeting ground in each zone for resolving issues/problems having inter-State/Centre-State/regional ramifications as well as for ensuring rapid and balanced socio-economic development of the respective regions. Although recommendations of these Councils are not binding, yet by convention, these have always been accorded high priority by all concerned in so far as their implementation is concerned. Further, being an advisory body, there is full scope for free and frank exchange of views at the meetings of these Councils, even on complex and intricate issues thereby ultimately often leading to amicable solutions to problems.

The **Southern Zonal Council comprises of the States of Andhra Pradesh, Karnataka, Kerala, Tamil Nadu and UT of Puducherry.** The Chief Minister and two other Ministers from each of the States in the Zone are the members of this Council.

Before the Zonal Council Secretariat initiates steps to convene the next meeting of the Council, it is necessary that sufficient number of items are sponsored by all concerned for consideration of the Council. I shall, therefore, be grateful if your Ministry could identify important economic, social and developmental issues/problems having inter-State and Centre-State ramifications concerning the States of the Southern Zone, for consideration at the next meeting of the **Southern Zonal Council.** Each item proposed for inclusion in the agenda may be accompanied by an explanatory memorandum both in hard & soft copies (by e mail at dir.iscs@nic.in) indicating therein:-

- Issue or issues involved with detailed background;
- Efforts made by the State Government to resolve them; and
- Specific points and issues on which recommendations of the Council are sought.
