

## CHAPTER - III

### UNREGISTERED SSI SECTOR

- 3.1 The Unregistered SSI Sector for the purpose of the Third Census was taken to be the set of all those enterprises which were eligible for registration as SSIs and SSSBEs but were not so registered as on March 31, 2001.

#### Structure of the Unregistered SSI Sector

- 3.2 The Unregistered SSI Sector was dominated by the presence of SSSBEs (64 %). The balance was accounted for, by SSIs out of which about 2.55% were Ancillary Units. The proportion of the units in the Unregistered SSI Sector operating from rural areas was 57.3 %.

#### Type of Organisation

- 3.3 97.2 % of the units in the Unregistered SSI Sector were proprietary units. About 1.25% of the units were run by partnerships and the rest were owned by either private companies or cooperatives or trusts.

#### Type of Management

- 3.4 10.66 % of the units in the Unregistered SSI Sector were Women Enterprises, whereas the number of units actually managed by women was 10.51 %. Socially, 9.06 % of the units were managed by Scheduled Caste (SC) Entrepreneurs, 3.17 % by Entrepreneurs belonging to Scheduled Tribe (ST) and 43.39 % by Entrepreneurs from Other Backward Classes (OBCs). Thus, 55.62 % of the units were managed by entrepreneurs from socially backward classes.

#### Employment

- 3.5 The per unit employment in the Unregistered SSI Sector was 2.11. The employment per rupees one lakh of investment in Fixed Assets was 1.71.

#### Main Source of Power

- 3.6 Electricity was the main source of power in the Unregistered SSI Sector as well with 47.98 % units making use of it whereas 42.11 % of the units did not require any power for their operations.

#### Nature of Activity

- 3.7 The pre-dominant number of the Units in the Unregistered SSI Sector were engaged in services (49.8%), whereas 33.6 % of the units were in manufacturing activities. The remaining 16.6 % of the units were engaged in repair and maintenance activities.

#### Outstanding Loan

- 3.8 About 6.1 % units in the Sector had outstanding loan against their names as on 31-3-2002 and 3.58 % had outstanding loan with institutional sources such as the Banks and Financial Institutions.



### Reasons for not Registering

- 3.9 The Registration for units in SSI Sector is voluntary. However, an attempt was made in the Census to know the reasons for not opting for Registration by the Units in the Sector. Interestingly, 52.29 % of the units informed that they were not aware of the provisions for Registration of the Units, while 40.57 % of the Units indicated that they were not interested. The following Table gives the details about the reasons for Non-Registration of the Units:

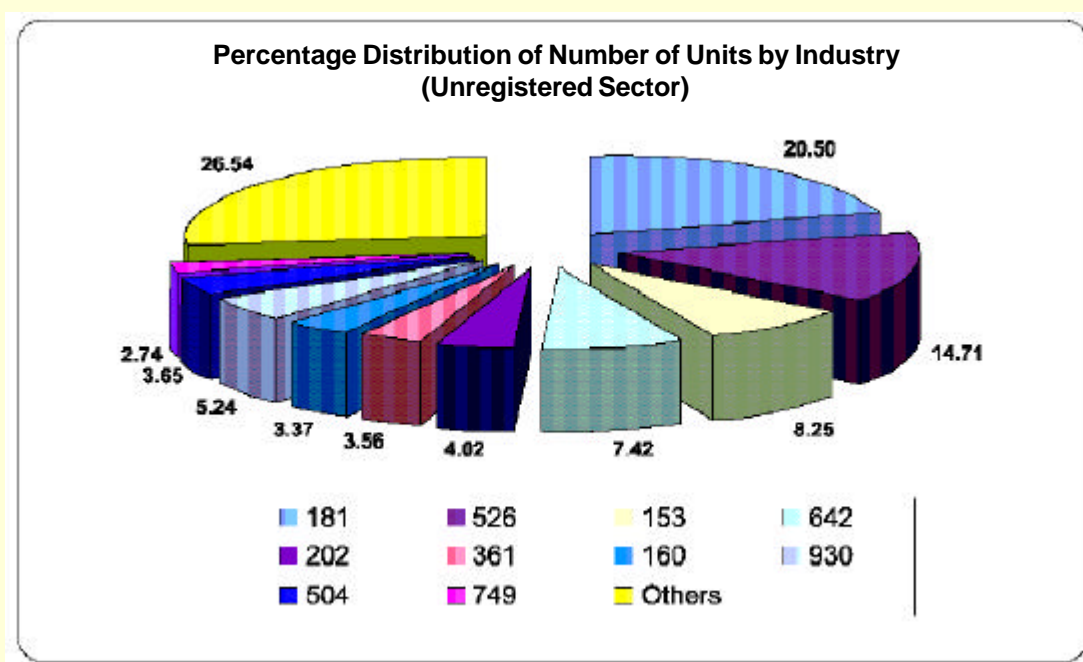

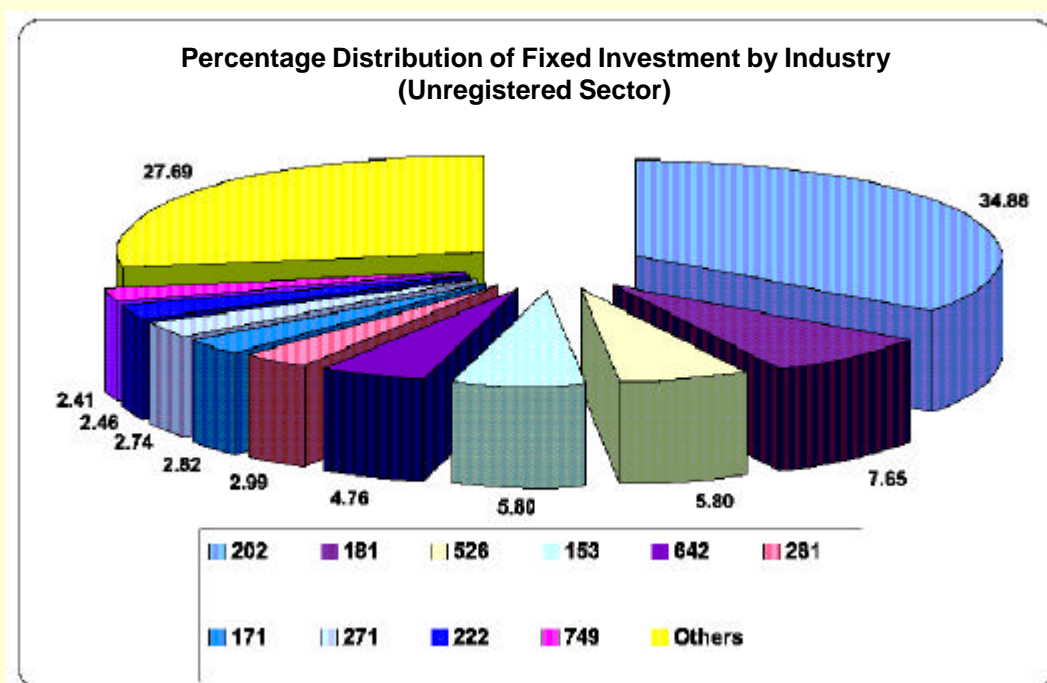

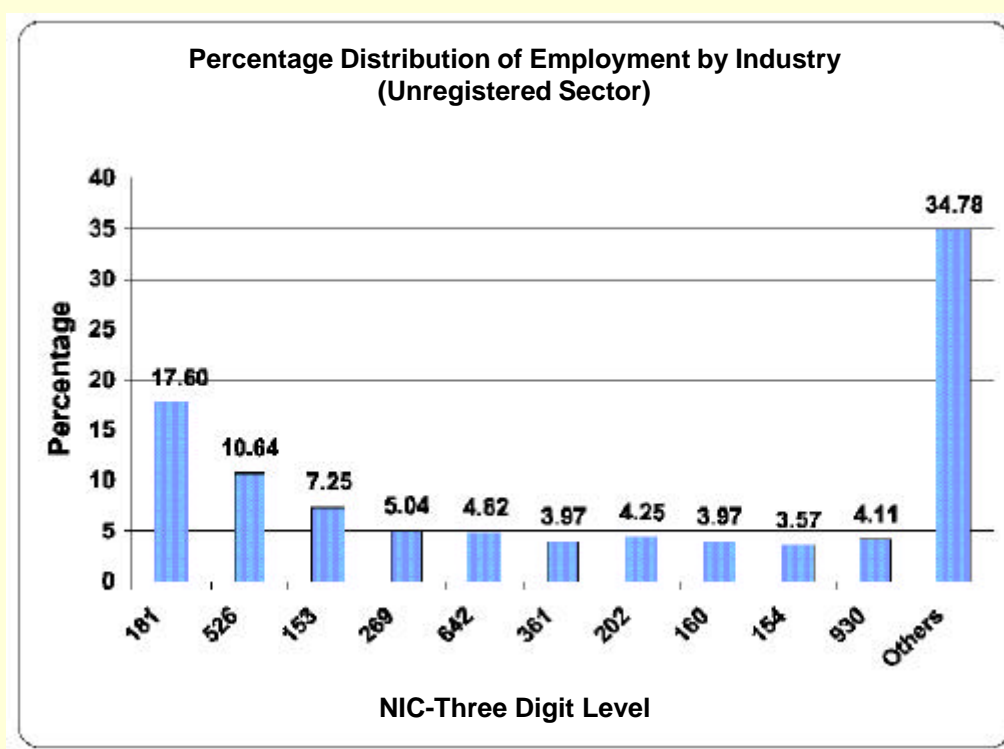
