CIRCULAR

**Issuance of Acknowledgement Part II as per the provisions of
Micro, Small and Medium Enterprises Development Act, 2006
(MSMED Act)**

01. The Department of Industries, Govt. of NCT of Delhi has been issuing Acknowledgement Part II under Sections 8 of the MSMED Act, 2006 to those Enterprises who file their Entrepreneurs Memorandum Part-II alongwith relevant/prescribed documents before the Nodal Officer i.e. Deputy Commissioner of Industries (MSME), Industries Department, GNCT of Delhi.
02. Whereas, an opinion was sought from the Law and Justice, Department of Govt. of NCT of Delhi about the requirement of "Delhi Pollution Control Committee (DPCC) order of "Consent to Operate" and valid Municipal Corporation License, at the time of filing of Entrepreneurs Memorandum Part-II.
03. Whereas, the Law and Justice Department of Govt. of NCT of Delhi has opined that the filing of Entrepreneurs Memorandum Part-II under the MSMED Act, 2006, the implementing ministry of the aforesaid Act is the Ministry of Micro, Small and Medium Enterprises, Government of India. Therefore, the administrative Department may take up the matter with the concerned Ministry to resolve the issues.
04. Whereas, the Ministry of MSME, Government of India vide letter dated 25th October, 2007 has already directed the Industries Department, Government of NCT of Delhi that Entrepreneur's Memorandum, notified in pursuance of Section-8 of MSMED Act, 2006, a legislation by the Parliament of India be implemented without any changes by Industries Department, Delhi Government.

05. In the light of the above position, it is hereby directed that enterprises who wish to file EM Part-II, can do so without submitting, "Delhi Pollution Control Committee (DPCC) order of "Consent to Operate" and valid Municipal Corporation License. However, a copy of EM-I and EM-II issued shall be endorsed to Delhi Pollution Control Committee (DPCC) and MCD for information.
06. A public notice is also being issued through two leading newspapers for the information of the general public.
07. The above issues with the prior approval of the Competent Authority.
