1. PROJECT BRIEF

Office of the Development Commissioner (MSME), Ministry of MSME, Government of India is in the process of upgrading and expanding the network of Technology Centres (TCs) - also referred to as Tool Rooms & Technology Development Centres by upgrading existing 18 TCs and establishing 15 New TCs at a total Project cost of INR 2,200 crores including World Bank funding of USD 200 million under the Technology Centre Systems Programme (TCSP). 3. REQUIRED QUALIFICATION AND EXPERIENCE

- Post Graduate degree/diploma in Science / Engineering / Economic disciplines.
- At least 15 years experience of working with State or Central Government or PSU at a level equivalent to Group 'A' level in Government of India with demonstrable exposure in socio-economic developmental issues.
- Demonstrable project formulation, implementation and/ or management experience for a World Bank / ADB / Multilateral funded Projects in India is a must.

2. ASSIGNMENT

It is the intent of the Government of India to appoint a National Program Manager (NPM), a full time functionary for TCSP who is be likely to continue till March 31, 2020. The position of NPM will be at the level equivalent to the Director / Joint Secretary in Government of India. The roles and responsibilities of the NPM will include:

- Day to day coordination of all technical inputs and implementation of field activities at the national level for the program
- Coordination between various stakeholders and ensuring delivery of program outcomes and smooth implementation
- Reviewing key project documentation, reporting and coordinating with various stakeholders for their approval.
- Closely monitor the progress of the program and the delivery of contractual commitments by all vendors engaged under the program
